Equis Financial **REQUIRES** one of two Anti Money Laundering Courses. One of these is the RegEd AML! This will be a free course for you, the agent. To get this deal, however, you **MUST** use this link (see below). If you do not, **we will not be able to reimburse you for any charges.** We also recommend that you bookmark this link since you will always need to use this link to log back into the course once registered.

You will also be presented with an option to use this course for Continuing Education with your state. You will want to opt out of this as this particular AML Course cannot be applied for

CE credits. Equis will also not be responsible for any fees accrued outside of the RegEd AML course.
